### INSTRUCTIONS FOR FILING TRANSIENT OCCUPANCY (TOT) TAX RETURN

- 1. Effective July 1, 2011, each transient occupant shall pay a tax in the amount of ten percent (10%) of the rent charged by the hotel or motel operator for occupying space for thirty (30) days or less.
- 2. A tax return must be delivered or postmarked to the Administrative Services Department, 8930 Limonite Avenue, Jurupa Valley, CA 92509 on or before the thirtieth (30<sup>th)</sup> day from the end of the reporting period. **EVEN IF THERE IS NOT TAX DUE.** If the due date falls on a Saturday, Sunday or Holiday, the next City business day will be the due date. Failure to pay TOT will result in penalties and interest being assessed.
- **3. DELINQUENT DATE:** The thirty-first (31<sup>th</sup>) day following the close of the reporting period is the delinquent date (e.g. March's monthly report and payment will be delinquent and subject to penalties and interest if received or postmarked after April 30<sup>th</sup>).
- **4. PENALTY SCHEDULE:** The following penalty rate will be added to the amount of tax owed: ten percent (10%) on the thirty-first (31<sup>st</sup>) day of the close of the reporting period.
- **5. INTEREST:** In addition to penalties, interest of 0.5% per month (6% per annum) for each month the tax is delinquent.
- 6. **PAYMENT:** Payment can either be made in person at the City Hall or by mail. The TOT Return Form, located on the City website, must be used when submitting your payment.
- **7. RECORDS SUBSTANTIATING THE TAX RETURN** must be retained by the operator for a period of not less than three (3) years from the date of payment.
- 8. ADDRESS OR OWNERSHIP CHANGE: Must be reported immediately to the Administrative Services Department. NOTE: TOT is due and payable immediately upon cessation of business for any reason (e.g. foreclosure, assignment of a receiver or sale of business).
