COVID-19 - COMMUNITY DEVELOPMENT BLOCK GRANT (CDBG) - PUBLIC SERVICE GRANTS

NOTICE OF FUNDING AVAILABILITY / REQUEST FOR APPLICATIONS

In response to the Coronavirus Pandemic (COVID-19), President Trump authorized the Coronavirus Aid, Relief, and Economic Security Act (CARES Act), Public Law 116-136 on March 27, 2020. As a result, the U.S. Department of Housing and Urban Development (HUD) awarded the City of Jurupa Valley \$702,928 in Community Development Block Grant Coronavirus (CDBG-CV) funds to prevent, prepare for, and respond to COVID-19. The City may allocate additional CDBG-CV or other funds as they are available through this solicitation. However, subsequent funding is not guaranteed, and there is no guarantee about the funding level.

The City of Jurupa Valley is free to select from a range of eligible activities established by HUD that would specifically 'prevent', 'prepare' or 'respond' to the COVID-19 pandemic with the use of CDBG funds. Eligible activities include social service programs (i.e., public services) provided the majority of program beneficiaries are low- and moderate-income residents, as defined by HUD and address the COVID-19 pandemic. Funding for public service programs is limited to a budget allotment established by the City that falls within CDBG program guidelines. The City has planned to make \$281,000 available for public services for Fiscal Year 2019-2020. Funding levels may be increased or decreased by City Staff due to need and/or other considerations.

REQUEST FOR APPLICATIONS

At this time, the City is accepting applications from interested, tax-exempt California nonprofit organizations currently providing or planning to provide eligible CDBG services within the City of Jurupa Valley during Fiscal Year 2019-2020. Interested/qualified organizations are invited to apply for public service programs funding. The CDBG application, along with additional information regarding the CDBG program as administered by the City of Jurupa Valley, is available for download from the City's website www.JurupaValley.org/CDBG or upon request at Jurupa Valley City Hall located at 8930 Limonite Avenue, Jurupa Valley, CA 92509, during normal business hours, Monday through Friday, 8:00 a.m. – 5:00 p.m.
