

PUBLIC NOTICE

In accordance with federal regulations [24 CFR 91], and applicable waivers made available through the Coronavirus Aid, Relief, and Economic Security Act of 2020 (CARES Act), notice is given that the City of Jurupa Valley is making amendments for the second time to the its 2018-2022 Consolidated Plan/2019-2020 Annual Action Plan. Jurupa Valley's 2018-2022 Consolidated Plan/2019-2020 Annual Action Plan was amended for the first time on June 4, 2020 when the City received its first allocation of CDBG-Coronavirus (CDBG-CV 1) funds.

Amendment

The amendments to the Jurupa Valley amended 2018-2022 Consolidated Plan/2019-2020 Annual Action Plan will enable the City of Jurupa Valley to receive and administer \$664,209 in Community Development Block Grant - Coronavirus (CDBG-CV) Round 3 funding allocated to the City by HUD. (Only States and insular areas received CDBG-CV Round 2 funding.) This amendment will add Round 3 CDBG-CV funds to the 2019-2020 Annual Action Plan for the following activities:
